OFFICIAL RULES

PRIZE

ENTRY PERIOD

The Sweepstakes begins on May 27, 2026 at 12:01 AM CDT and ends on June 4, 2026 at 11:59 PM CDT (“Entry Period”). Entries submitted after the Entry Period will not be eligible.

ELIGIBILITY

The Sweepstakes is open only to legal residents of the United States who meet all of the following requirements at the time of entry:

- Participant must be at least five (5) years old by June 8, 2026
- Participant must be entering 1st through 10th grade for the upcoming school year

Parents or legal guardians must complete the entry form on behalf of participants under the age of 18.

If a selected winner does not respond within the required timeframe, is found to be ineligible, or fails to comply with these Official Rules, an alternate winner may be selected at Sponsor's discretion.
